I. CALL TO ORDER: Randy Angst called the meeting to order at 10:02 a.m.

II. LEGISLATIVE UPDATE:

- i. **Mike Ussery (Senator Schmitt)** The senator is happy about a couple of court rulings; the Supreme Court denied student loan forgiveness as well as a federal judge restricting the Biden administration from communicating with tech companies. Senator Schmitt is also asking the U.S. Department of Agriculture secretary to explore options to open Conservation Reserve Program land for emergency haying.
- ii. Payton Ruddy (Rep. Mark Alford) Rep. Alford reintroduced the SERV Act, a bipartisan bill to support veteran entrepreneurs. It has been announced that the government will use \$50 million for new housing at Fort Leonard Wood. There will be a farm bill listening session on August 14, 2023, at the Missouri State Fair, Payton urged everyone to go.

Kyle stated LOCLG is having a challenging time getting volunteers to participate with HSTP project. K.C. Cloke asked what LOCLG can do to get more participation. She is going to send Kyle a template letter to give to the volunteers to urge more activity.

Kyle wants to create financial and marketing committees to help control the budget and ways to market LOCLG. He is looking for volunteers to sit on these committees. Brian Thompson asked who the customers are, and Kyle explained small governments and he wants to send out surveys and have meetings to tailor LOCLG services to all small governments in our region.

IX. NEW BUSINESS -

i. Rock Island Trail Announcement

Kyle Elliott and Jamie Morrow attended the Windsor announcement of the Rock Island Trail. It was a great turnout; communities are working together to build the trail across the state. Jamie Morrow has been approved for a TAP grant in Versailles. Don Abbott is working on a TAP grant as well.

ii. Website/Facebook Update

Erik Ackerson updated the LOCLG website and created a new Facebook page. He explained the need for changes and the redesign of both pages. There are still two outdated Facebook sites that have been considered "dead" by Facebook, but they cannot be removed.

iii. LOCLG Marketing Strategy

Kyle Elliott explained we did not have a vision/mission statement. Kyle also explained the team is working to update the employee handbook, as well as the policy and procedures. Mike Koenigsman brought up that the board members should also approve of any changes wanting to be adopted. The board would like to discuss the old verses the new vision/mission statements at the next board meeting.

iv. County Artwork/Pictures

Kyle asked the board for any artwork they would like to donate to decorate the office. Heather Brown stated they have many photos the LOCLG could use. Jamie Knipp stated that the office is looking for framed artwork so as not to use money from the budget.

v. Transportation Alternatives Program

Kyle Elliott gave the details for TAP grants. It is an 80/20 match, with a minimum of \$100,000 and maximum of \$500,000. The team is looking for projects and clients to help facilitate the grants. Samantha Skidmore explained that if you have a large project over \$500,000, it is possible to apply for two loans.

vi. Laclede County Hazard Mitigation

Kyle Elliott stated the Laclede HMP is about 30% complete. Erik Ackerson has written three out of five sections.

X. EXECUTIVE BOARD

i. The executive board went into a special session to discuss job positions. No vote was taken. Heather made a motion to return to regular session. Jamie Morrow offered the second motion.
